The Grantor hereby conveys to the Grantee the lands described in the Schedule marked "A" hereto annexed.

LOT NO. 1

ALL THAT CERTAIN lot of land situate at Riverton, in the County of Pictou and Province of Nova Scotia, abutted and bounded as follows: BEGINNING at a stone placed at the boundary or line of the western side of the Public Road leading to Hopewell and running southwest twenty six rods to the public road to a stone there placed;

THENCE northerly along the line of the said Road to the place of beginning to a stone there placed, containing one-half acre more or less.

BEING AND INTENDED TO BE the same land as conveyed by Deed dated November 28th, 1887 from Thomas Grant and wife to Trustees of School Section No. 9 Riverton and recorded at the Registry of Deeds office, Pictou on January 12th, 1888 in Book 90 Page 743.

ALL THAT lot, piece or parcel of land situate, lying and being at Riverton, in the County of Pictou and Province of Nova Scotia, more fully described as follows:

BEING PART of a lot of land conveyed by Margaret Jane Fraser to His Majesty the King by deed registered at the office of the Registrar of Deeds at Pictou on December 21st, 1937, Book 263, Page 187, bounded on the south and southwest by the Riverton Cemetery Lot;

ON THE EAST by lands of Roy Grant and ON THE NORTH by the southern boundary of the original Eureka-Stellarton Highway and the southern boundary of the division of said Eureka-Stellarton Highway as constructed in 1937, containing 1.23 acres, a little more or less, as shown in red outline on the attached plan.
